GENERAL TERMS & CONDITIONS

GUARDIANS OF NATURE FOUNDATION

1. INTRODUCTION - DEFINITIONS AND PROVISIONS

1.1. Website: an access point on the internet, available under the domain name www.guardiansofnature.foundation, which website is exclusively owned and operated by Guardians of Nature Foundation, including any and all functions and mobile applications belonging to and/or relating to the Website in any way.

1.2. Visitor / Client / User: a party using the Website or any function thereof in any way. Such natural or legal person who contacts or has contacted Guardians of Nature Foundation via the Website, e-mail, phone, personally or in any other way in order to - possibly - use the company's services and, during such procedure, provides his/her data listed in the Data Processing and Data Protection Policy, or, in case of a legal entity, provides the personal data of its representative and/or contact person.

1.3. Sponsor/Donor: a Visitor/Customer/User who uses the services of the Website and makes a donation to the Foundation's account at least once. A receipt is issued for the payment.

1.4. Gift/Gift item: any tangible, material service displayed on the Website, which is the result of the Visitor's / Customer's / User's purposeful activity.

1.5. Donation collection area: when you make a donation to our Foundation on the Website, this is where we indicate the exact amount of the donation and the gift item you have chosen.

1.6. Operator: the operator of the Website, the business association specified in the impress.

1.7. Contract: Contains the terms and conditions of the agreement made and entered into by and between Guardians of Nature Foundation and the Visitor (General Terms & Conditions of Use), and governs the contractual relationship of Guardians of Nature Foundation and the Visitor.

Any reference to the Terms & Conditions of Use in the singular shall always include the plural and the plural shall always include the singular. Any reference using the definite article shall also include the indefinite article and references using the indefinite article shall include the definite article.

1.8. Parties: Guardians of Nature Foundation and the Visitor are collectively referred to as Parties.

1.9. Competent authorities: administrative authorities having competence and jurisdiction.

1.10. Applicable law: regulations and acts detailed and specified below; with regard to disputes not regulated herein, the relevant provisions of the Civil Code shall apply.

1.11. Place of concluding the contract: the registered office of the Foundation.

1.12. Force majeure: (circumstances beyond control) means any and all circumstances or situations that are beyond the control of the given person and which result in delaying or preventing the given party from performing their contractual obligations, and which, in case of the general terms & conditions of use, shall include natural disasters, governmental restrictions (including the rejection or deletion of a permission, if such rejection or deletion is not attributable to the given party), wars, civil disorder, riots, acts of terror, fire, explosions, floods, thefts, wilful vandalism, strikes, preventing access and/or any other circumstance that is beyond the affected party's control.

The objective of our foundation is to preserve non-used wooden materials and wooden beams for posterity, to support and protect environment protection efforts/natural resources; to support and protect wildlife; to support and protect ecosystems and natural habitats; to support, protect and increase the woodlands of the planet; to support foundations and environmental protection organisations; to support animal welfare organisations.

This is how we developed our theory "Nature's Guardians". We want to spread this movement online and offline as widely as possible.

A gift of an old tree, at the level of your contribution, represents your contribution to the protection of the environment; the promotion and protection of natural resources; the promotion and protection of wildlife; the promotion and protection of ecosystems and habitats; the promotion, protection and enhancement of the world's tree population; the support of foundations and environmental organisations; the support of animal welfare organisations.

In addition, through our website, you have the opportunity to participate as a Featured Sponsor by donating additional funds beyond the gift items you request, which will also support the above objectives.

3.1.2. Gifts/Gift Items: our Foundation makes unique "Handmade" gift items for our Supporters from last century or older, mainly dismantled, unused wooden beams. The uniqueness of the gift item is that we keep the material in its original state, we leave the rings of the year visible, which can show the age of the old wood to symbolize our theory, it is completely natural to bring nature closer to people, and we add unique pictures, even your own picture, to make the Sponsor feel completely at home. We have the inscriptions on the Trees made using special laser machines that process old wooden beams to burn the pattern into a piece of wood, giving the souvenir hundreds of years of additional durability. Custom wood pieces can be made with your own photographs on our online platform, where we have developed a process to convert the photograph for the Sponsor so that the image on the tree is perfectly in sync with the final Gift Tree and gives a unique feel to the Sponsor.

On the website, the image upload and image editing functions are available without registration, and the uploaded data is only stored once the purchase process is complete.

Gift items made from dismantled timber from the last century or older are not completely uniform due to their age and original functional use, they may show signs of dismantling such as stretching, nailing, cleaning, in some cases cracks may be present due to drying, and the colour and hardness of the wood may vary due to the warping.

As we are constantly saving and processing old pieces of wood and each piece is different, we are not able to give our Sponsors any information in advance about the surface of the Wooden Gift Item, the condition of the Wooden Gift Item, and the Sponsor accepts this. These conditions are shaped by time and nature, which we have no control over, we just process them, have them cleaned, put them in a non-damaging condition. The size of the wooden gifts always varies between a 30-10 cm wide band, a 25-10 cm high band and a 5-10 cm deep band, from these dimensions the wooden gift itself cannot be different.

The donor also has the option to choose a unique "Handmade" utility item, an old wooden chest backing, which can be used to store different items depending on the user. You can find photo ideas for their palette of uses on our website.

The Sponsor also has the option to choose a unique "Handmade" photo album gift item at the time of donation. Depending on the template, 1-10 wooden photo cards will be placed on the 20x27 cm surface of the single-sided photo album. You can find display ideas for these on our website. The double-sided photo album 2x20x27 cm has 2-20 wooden photo cards, depending on the template. You can find display ideas on our website.

In view of the above, laser cutting the wood does not necessarily provide a homogeneous surface, so some parts of the photo and text may be missing due to gaps, cracks and decades of drying, but these missing parts are what make the Gift unique, old and unrepeatable.

We cannot guarantee the quality and sharpness of the images uploaded by the user, which will appear on the wood and on certain parts of the box, as they are provided by the user and are out of our control!

3.1.3. Non-governmental movement/organisation for the environmental protection and for fighting climate change

Our objective is to create a network around the world, which responsibly takes care of environmental protection and the increase of the woodlands of the Earth in the long run while also providing some kind of gift for the contributors/customers. With regard to the objectives described in Section 3.1.1., in cooperation with non-governmental organisations, we wish to unite the citizens of the world, and by increasing the woodlands of the world or supporting the nature otherwise we are enabling our environment to renew constantly.

3.1.4. Support process, payment systems

The Supporter has the possibility to make a donation through our website to help us achieve our objectives, which will be summarised in the Supporter collection area mentioned in section 1.5. To the extent of the contribution paid, you have the possibility to request a Gift Aid item, which will be illustrated with pictures on our website.

Once the grant amount has been sent and the Gift Item has been selected, the amount of the grant paid and the shipping cost of the Gift Item will be displayed separately in the Sponsor Summary. The shipping cost varies by country. During the process of sending the amount of support, our system will also request personal data from you, which you can find out about in the Data management, data protection and data security section. If you do not complete the sections marked with an asterisk, the process is not complete.

The Supporter can send a donation to support the objectives of our Foundation through a PayPal account or by credit card payment. When making a payment, the payment module integrated in our Website can be used, the bank details can only be entered in the interface of the contracted bank, the card details are not visible to the operator. Payment by bank card is only possible for customers who have activated bank security services, specifically strong customer authentication, which may vary from bank to bank: sms code, QR code or other message, so that the Sponsor can see the transaction has been made.

When paying the grant amount and/or claiming the Gift, our Foundation has contracted with OTP Bank Plc. for the payment by credit card, so the Sponsor can make payments in the following currencies via OTP simplepay pos: HUF, USD, EUR.

If the Customer is visiting our Website from a non-Hungarian IP address and/or from a non-Hungarian browser, he/she can make payments via Paypal payment system or via OTP Simplepay pos system in the following currencies.

We are not able to exchange the sent Gift Items, and our Foundation is not liable for any damage caused during the mailing process and has no other warranties!

3.1.5. The Gift Items will be selected by the Sponsor based on the donation made, as indicated on our website.

Our Foundation shall not be liable for any damages resulting from the use of the website, any defects, errors, unusability, malicious viruses, content, data transmission errors. Also, information, files, documents, printed materials published by third parties that may be brought in connection with our website.

3.1.6. We deliver the finished Gift Items to your home through our partners. You may not deviate from these partners and may not request another company to deliver the Gift Item. The shipping cost is listed under the Gift Item(s) in the Sponsor Collection Area and must be paid in advance, together with the donations if you are requesting a Gift Item.

3.2. Intellectual property

3.2.1. The Visitor shall not have the right to make a copy of, modify, counterfeit or reproduce a part or the whole of the Website without the prior written consent of Guardians of Nature Foundation.

3.2.2. If any of the provisions specified in Section 3.2.1 is violated by the Visitor, Guardians of Nature Foundation will report that to the police and initiate proceedings for the payment of compensation as a result of violating intellectual property rights.

3.3 Links on the Website (partners)

3.3.1. 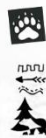

The gift items sent by the Guardians of Nature Foundation are made of dismantled logs from the last century or older, are not exactly the same due to their age or original functional use, may show signs of dismantling such as splitting, nailing, cleaning, in some cases cracks or gaps in the wood due to drying, and may vary in colour and hardness due to the warping.

The raw material for the photo album and wall crate backing is old salvaged wooden crates, which may have warps, different colour shades, different thicknesses of material, but surface cleaning and sanding is applied before the souvenirs are manufactured.

During the laser cutting process, the wood may not provide a homogeneous surface, so some parts of the photo and textures may be missing due to gaps, cracks and decades of drying, but these missing parts are what make the Gift Object look unique, old and unrepeatable.

As we are constantly salvaging and refinishing old pieces of wood, and each piece is different from the next, it is not possible for us to give our Sponsors advance notice of what the finish of the Gift Item will look like, and the condition of the Gift Item is accepted by the Sponsor. These conditions are shaped by time and nature, which our Foundation has no control over, only to have them processed, cleaned, and thus brought to a non-damaging condition.

6. LOSSES OR DAMAGES

6.1. Guardians of Nature Foundation shall not be held liable for any damages (including property damages and non-property damages) or losses, directly or indirectly, suffered by the Visitor as a result of using the Website, in particular, but not exclusively, for material losses, for losses of profit, for losses of expected income, profit or any other gains, for business losses, for losses of business information or for any other property or collateral damages.
